- o USD 250.00 per person or USD 1.000.00 per family per arrival, and
- 200 cigarettes or 25 cigars or 100 grams of sliced tobacco or other tobacco product, and 1 liter drinks containing ethyl alcohol for every adult.

Crew who brings/carries goods for personal use that were purchased or obtained abroad and will remain in Indonesia, is entitled to an exemption of import duties, excise, and taxes of those goods at the most:

- o USD 50.00 per person per arrival, and
- 40 cigarettes or 10 cigars or 40 grams of sliced tobacco or other tobacco products, and 350 mililiter drinks containing ethyl alcohol.

If you are bringing commercial merchandise into Indonesia, the merchandise is subject to import duty and other import taxes.

Please notify Customs Officer, in case you are bringing currency and/or bearer negotiable instruments (cheque, travellers cheque, promissory notes, giro) in Rupiah or other currencies which equal to the amount of 100 million Rupiah or more.

Should you have unaccompanied baggages, please duplicate this Customs Declaration and request an approval to Customs Officer for claiming the unaccompanied baggages.

To expedite the customs services, please notify the goods that you are bringing/carrying completely and correctly in this form, then submit it to Customs Officer.

Making a false declaration constitutes serious offences which attract penalties or punishment in accordance with laws and regulation.
